



Prevention Educator

Pathways of Central Ohio seeks a dynamic professional to join its Center for Prevention Services. Established in 1968, Pathways is a not-for-profit social service organization. The Center for Prevention Services provides programming in Licking County.

Job Description

The Prevention Educator's primary responsibilities involve the direct delivery of services in school and community settings. The Prevention Educator may represent the agency on relevant committees and share data with the community regarding unmet needs and advocate for needed services.

Within the scope of work is engaging community partners, motivating community change and participating on local coalitions. In addition, the Prevention Educator provides direct service utilizing such curriculums as Too Good for Drugs, Too Good for Violence, Project Alert and LifeSkills. The Prevention Educator is also responsible for completing reports and helping to evaluating outcomes.

The Center for Prevention Services currently employs two other full-time staff and is certified as a Prevention Program by the Ohio Department of Mental Health and Addiction Services.

Qualifications

- Certified Prevention Specialist (CPSA, CPS, CPC or eligible for certification) preferred.
- Bachelor's degree in behavioral health, public health or related field required.
- A minimum of two years work experience in behavioral health or related field; prevention-specific experience preferred.
- Strong organizational and time management skills
- Ability to present classroom curricula to various age groups (grades 3-12)
- Valid driver's license and proof of insurance.
- Successfully pass B.C.I. background check.
- Ability to independently operate a personal computer and utilize a variety of software programs including Microsoft Office.
- Ability to effectively communicate orally and in writing in a clear, concise manner, tailoring messages to the intended audience.
- Ability to work within a remote setting such as Zoom and/or Google Classroom and effectively communicate orally in remote setting.
- Ability to record videos on personal device related to prevention material used by agency, edit and upload to Dropbox for approval.
- Ability to work from home remotely/independently while following business hours and expectations required when working in the building.
